ADMISSION POLICY FOR SEPTEMBER 2026 – AUGUST 2027, updated Nov 2025

The School has a distinctive Christian ethos which is embodied in our Vision Statement:

'This is the day that the Lord has made, let us rejoice and be glad in it.' Psalm 118

Our vision is for our pupils and staff to feel cared for unconditionally and valued as a unique creation in our learning, play and rest. We want to help them to approach each day now and in the future with gratitude and high aspirations. We encourage them to reflect and pray.

As a church school, we welcome applications from Christian families, and those of other faiths or none. We ask all parents applying for a place at our school to respect this ethos and its importance to the whole school community.

The governors have made every effort to ensure that these arrangements comply with the School Admissions Code 2021 and all relevant legislation, including that on infant class sizes and equal opportunities.

Admission arrangements to the Reception Year in September 2026

At our school, pupils are normally admitted at the beginning of the school year (1 September – 31 August) in which they reach their fifth birthday. Parents whose children were born between 1 September 2021 and 31 August 2022 may apply for them to be admitted to the Reception Year in September 2026. **There are 17 places** (the published admission number) **available**.

Parents of a child born between 1 Sept 2021 and 31 March 2022 may defer entry until their child reaches compulsory school age (the term beginning in January or April after his or her fifth birthday). The school will hold the deferred place for the child, (provided it is taken up during the school year 2026 - 27) although, in the majority of cases, we find that children benefit from starting at the beginning of the school year, rather than part way through it.

For children born between 1 April 2022 and 31 August 2022 (summer-born children) parents can defer the date that their child is admitted to school but not beyond the beginning of the final term of the school year. Parents should refer to DfE Guidance on requesting a delayed school start for children born in the summer: Summer born children: advice for parents.

Until the child reaches compulsory school age, s/he may attend part-time. If parents wish to exercise this right, they should discuss detailed arrangements with the head teacher.

Parents (see Note 1) wishing to apply for the Reception [Foundation] Year in September 2026 must complete the common application form provided by their home local authority (the home LA). The home LA is the LA in whose area the parents live at the time of the application. The form must be returned to that LA no later than 15 January 2026. Applications received after this date will normally only be considered after all those received on or before the cut-off date. Offers and refusals of places will be given to parents on 16 April 2026.

Over-subscription criteria

Children with an Education, Health and Care (EHC) plan naming Finchampstead Church of England (Aided) Primary School will always be offered places.

If there are fewer applications than places available, all children will be offered places. If there is greater demand for admission than there are places available, the following criteria will be applied in the order set out below:

- 1 Looked-after children and children who were previously looked after, including those children who appear to have been in state care outside England, but ceased to be so as a result of being adopted. (see Note 2).
- 2 Children with a normal home address (see Note 3) **in the catchment area** (see Note 4) **and** who (or whose family) have (has) exceptional medical or social needs that make it essential that the children attend Finchampstead Church of England (Aided) Primary School rather than any other. These needs must be fully supported by written evidence from the appropriate professional person involved with the family (see Note 5).
- 3 Children with a normal home address (see Note 3) **in the catchment area** (see Note 4) **and** with a sibling (see Note 6) on the roll of the school at the time of application or whose parent has accepted an offer of a place at the school and who is expected still to be in attendance at the time of entry to the school.
- 4 Children with a normal home address (see Note 3) **in the catchment area** (see Note 4).
- 5 Children with a normal home address (see Note 3) **outside the catchment area** (see Note 4) **and** with a sibling (see Note 6) on the roll of the school at the time of application or whose parent has accepted an offer of a place at the school and who is expected still to be in attendance at the time of entry to the school.
- 6 Children with a normal home address (see Note 3) **outside the catchment area** (see Note 4) who (or whose family) have (has) exceptional medical or social needs that make it essential that the children attend Finchampstead Church of England (Aided) Primary School rather than any other. These needs must be fully supported by written evidence from the appropriate professional person involved with the family (see Note 5).
- 7 Other children.

Proximity of the child's home, as measured by the radial (straight line) distance (see Note 7) between the home and the school with those living nearer being accorded the higher priority, will serve to differentiate between children in criteria 1 to 7 should the need arise. In the event that two distance measurements are identical, the school will use random allocation to decide which child should be offered the place. The process of drawing lots will be conducted in the presence of a person independent of the school.

All Other Admissions

Admission to the school during the school year depends on whether or not there are places available. **All year groups at the school have 17 places.** Applications must be made directly to the Wokingham LA on a form available from Wokingham LA with whom the school has a voluntary co-ordination arrangement.

If there is a vacancy, and there is no child on the relevant waiting list with a higher priority (according to the over-subscription criteria 1 – 7 above), a place will be offered.

In-year admissions or admissions at the beginning of school years other than Reception may be made at any time. The LA and Governing Board will only consider applications up to half a term [using the three term year] in advance of the desired date for entry. For example, for entry in January, the application will not be considered until after the October half term break.

Admission outside normal age group

Requests from parents for places outside a normal age group will be considered carefully e.g. for those previously educated abroad or who have missed education due to ill health. A parent of a summer-born child who wishes their child to start in the autumn term following their 5th birthday (ie in the Reception Year rather than Year 1) should refer to: DfE Guidance: Making a request for admission out of the normal age group.

Each case will be considered on its own merits and circumstances and a decision made based on what is in the child's best interests. It is recommended that parents discuss their wishes with the head teacher at the earliest opportunity. The Governing Board may ask relevant professionals for their opinion.

If a place in the requested age group is refused, but one in the normal age group is offered, then there is no right of appeal.

Waiting Lists/ Continued Interest Lists

The school and Wokingham LA maintain waiting lists for those children who are not offered a place. For those applying through the normal admissions round for entry, the Waiting List will be maintained from shortly following initial allocation in the year preceding the start of the academic year in September until 31 December following the start of the academic year in their Reception year.

The list will be re-ranked in accordance with the published oversubscription criteria each time that a name is added to or removed from the list.

Multiple births

In the case of twins, triplets etc or same cohort siblings where there are insufficient places available for all the children, the school will offer places in an order drawn by random allocation (multiple births) or to the eldest (birth dates in the same school year) up to the stated maximum of 17. The process will be conducted in the presence of a person independent of the school. If this results in splitting the family, parents may wish to decline the offer and seek places for all their children elsewhere. The school has to take this stance because of pressure on classroom space at Key Stage 2 (Juniors) when two year groups of 17 are together in one classroom.

Fair Access

The school participates in Wokingham LA's Fair Access Protocol. Children qualifying under the Fair Access Protocol may be offered a place even if there are no places available in the relevant year group and also take priority for admission over any child on the waiting list.

Appeals

Any parent not offered a place for their child at their preferred school has the right of appeal to an independent appeals panel. Details of appeals arrangements are available from the school, including the date by which an appeal should be submitted. In the event of an unsuccessful appeal against non-admission to the school, the school will not consider any further application in the same school year (1 September – 31 August), unless there has been a material change in circumstances, for example a change of address which results in a move from outside the catchment area to inside it.

Notes

Note 1 “Parent” is defined in law (The Education Act 1996) as either:

- any person who has ‘parental responsibility’ (defined in the Children Act 1989) for the child or young person; or
- any person who has care of the child or young person.

If you are in any doubt, please contact the school for advice.

Note 2 By a “looked-after child” we mean one in the care of a local authority or being provided with accommodation by a local authority in the exercise of its functions. Previously looked after children are children who have been adopted, subject to child arrangement orders or special guardianship orders. Adopted children are those for whom an adoption order is made under the Adoption Act 1976 (Section 12) or the Adoption and Children Act 2002 (Section 46). A ‘child arrangements order’ is one settling the arrangements to be made as to the person with whom the child is to live (Children Act 1989, Section 8, as amended by the Children and Families Act 2014, Section 14). A ‘special guardianship order’ is one appointing one or more individuals to be a child’s special guardian/s (Children Act 1989, Section 14A).

Applications under this criterion must be accompanied by evidence to show that the child is looked after or was previously looked after (e.g. a copy of the adoption, child arrangements or special guardianship order). Evidence that a child from outside England was previously in state care will be required to come within this criterion. A child is regarded as being in state care outside England if they were in the care of or were accommodated by a public authority, a religious organisation, or any other provider of care whose sole or main purpose is to benefit society.

Note 3 By “normal home address”, we mean where the child normally lives. This must be where the parent or legal carer of the child lives with the child unless it is shown that the child is resident elsewhere with someone else who has legal care and control of the child. The address should be a residential property that is owned, leased or rented by the child’s parent/s or person with legal care and control of the child.

Where a child lives with parents with shared responsibility, each for part of a week or month, the address where the child lives will be determined having regard to a joint declaration from the parents stating the exact pattern of residence. If the residence is not split equally, then the relevant address used will be that at which the child spends the majority of the school week.

Where there is an equal split or there is any doubt about residence, the home address will be assumed to be the address at which the child is registered with a GP.

We may ask for evidence of the normal home address in the form of a recent bill, for example, the most recent Council Tax bill, utility bill no more than three months old, a current TV licence, buildings and contents insurance, mortgage statement or rent book which shows the address concerned. Parents who are unable to provide this evidence should contact the school to discuss what evidence might be acceptable.

If a place at the school is offered, and it later becomes clear that the offer was made on fraudulent or misleading information (e.g. a false claim to living in the catchment area), and the school has denied a place to a child with a stronger claim, the school will withdraw the offer of a place. The offer can be withdrawn even after the child has started at the school.

If parents are moving house, evidence of the move will be requested when considering any application for a place. Documentary evidence in the form of a solicitor’s letter to confirm exchange of contracts, or a rental agreement for at least a period of six months will be required.

If parents move house after the application has been made, but before any offer of a place has been made, the home LA must be informed.

An address of a second home with the main home being elsewhere will not be accepted. If there are two or more homes, or where a family is returning from elsewhere, evidence will be required of the main home. An allocation of a place based on an address which might be considered only temporary or where the address given is a second home will not be made.

An address where the child was resident other than with a parent or carer unless this was part of a fostering or formal care arrangement will not be accepted.

There are special arrangements for families of service personnel with a confirmed posting or crown servants returning from overseas. If the application is accompanied by an official letter that declares the relocation date, and if there is a place available, it will be offered even though there is not an intended address or the family is not yet living in the area.

Note 4 By “catchment area” we mean the ecclesiastical parish of Finchampstead & California as defined by the solid red boundary on the map attached.

Note 5 When applying under criterion 2 or 6 (exceptional medical or social needs), you must include supporting evidence from an independent professional person which clearly demonstrates why the school is the most suitable and must illustrate the difficulties that would be caused if your child had to attend another school. The person supplying the evidence should be a doctor, health visitor, social worker, etc. who is aware of your child’s or your own case. The school reserves the right to ask for further evidence or clarification where necessary and may seek the advice of appropriate educational professionals where necessary.

Note 6 By “sibling” we mean a natural brother or sister, half brother or sister, adopted brother or sister, step brother or sister, or the child of the parent’s/carer’s partner where the child for whom the school place is sought is living in the same family unit at the same address as that sibling. It is helpful if parents make it clear on the application form where the sibling has a different family name. Where there is more than one sibling at the school, only the youngest should be listed on the application form.

Note 7 The radial (straight line) distance used to determine proximity of the home to the school will be measured by Wokingham LA’s Geographical Information System.
